

Burglary and Theft Endorsement

In consideration of separate premium charged for this coverage, this policy is extended to cover Burglary and Theft coverage as follows:

1. Coverage Provided

This endorsement is extended to cover physical loss or damage from Burglary and Theft and is subject to all the terms and conditions of the policy, except exclusion E. Perils Excluded Group I. Burglary and Theft is deleted in its entirety. This endorsement will not cover physical loss or damage caused directly or indirectly by or resulting from fire regardless of any other cause or event contributing concurrently or in any other sequence to the loss.

2. Limit of Liability

The company's maximum limit of liability for any loss under this endorsement will not exceed the limit of liability shown in the declarations.

3. Deductible Clause

This company will not be liable for loss or damage in any one occurrence until the amount of loss or damage exceeds the deductible amount shown in the declarations.

4. Definition

Burglary and Theft means burglary and theft with or without actual forcible and violent entry, or by a person feloniously concealed on any premises, or consequent upon threat of violence or violent intimidation, or of property in the open air.

All other terms and conditions of this policy remain unchanged.
